**LOCAL LAW NUMBER 1 - 2017
COUNTY OF CATTARAUGUS, NEW YORK**

Pursuant to Section 10 of the Municipal Home Rule Law.

**A LOCAL LAW ESTABLISHING FEES FOR CATTARAUGUS COUNTY
HEALTH DEPARTMENT SERVICES AND REPEALING LOCAL LAW
NUMBER 3-2011 (INTRO NUMBER 3-2011), AS AMENDED**

BE IT ENACTED by the County Legislature of the County of Cattaraugus as follows:

SECTION 1. Legislative Intent. It is the intent of this Local Law to revise the fee schedule currently in effect for certain services provided by the Cattaraugus County Health Department.

SECTION 2. Fee Schedule. Effective May 1, 2017, the following fees shall be charged by the Cattaraugus County Health Department.

If any provision of this Local Law shall be adjudged by any court of competent jurisdiction to be invalid, then such adjudication, shall not effect, impair or invalidate the remainder thereof, but shall be confined in its operation to the particular provision directly involved in the controversy in which such judgment shall have been rendered.

SECTION 4. Repeal Local Law Number 3-2011, as amended. Local Law Number 3-2011 (Intro Number 3-2011), as amended, is hereby repealed.

SECTION 5. Effective Date. This Local Law shall take effect immediately.

**ABOLISHING ONE (1) FULL-TIME POSITION OF PUBLIC HEALTH SANITARIAN,
CREATING ONE (1) FULL-TIME POSITION OF PUBLIC HEALTH SANITARIAN TRAINEE,
AND ESTABLISHING COMPENSATION FOR THE SAME
(Health Department)**

Pursuant to Sections 204 and 205 of the County Law and
Section 22 of the Civil Service Law.

I. WHEREAS, the Health Department must employ qualified individuals to provide public health sanitarian services, and

II. WHEREAS, due to the retirement of the incumbent Public Health Sanitarian, a new hire must complete training and certification with the State Department of Public Health before serving as a Public Health Sanitarian, and

III. WHEREAS, creating a trainee position will meet quality assurance requirements as well as training requirements established by the State Health Department, and

IV. WHEREAS, a New Position Duties Statement has been submitted to the Cattaraugus County Personnel Officer, who has approved the title as Public Health Sanitarian Trainee in accordance with Civil Service Law Section 22, now, therefore, be it

I. RESOLVED, that effective ~~immediately~~ **March 30, 2017**, there is hereby abolished one (1) full-time position of Public Health Sanitarian in the Health Department, Position No. 401-266-009, and be it further

II. RESOLVED, that effective ~~immediately~~ **March 30, 2017**, there is hereby created one (1) position of Public Health Sanitarian Trainee in the Health Department to be filled on a full-time basis, General Bargaining Unit Salary Schedule, Pay Grade 24 (\$24.60 per hour), Position No. 401-289-001.
