## LOCAL LAW NUMBER 1 - 2017 COUNTY OF CATTARAUGUS, NEW YORK

Pursuant to Section 10 of the Municipal Home Rule Law.

## A LOCAL LAW ESTABLISHING FEES FOR CATTARAUGUS COUNTY HEALTH DEPARTMENT SERVICES AND REPEALING LOCAL LAW NUMBER 3-2011 (INTRO NUMBER 3-2011), AS AMENDED

BE IT ENACTED by the County Legislature of the County of Cattaraugus as follows:

<u>SECTION 1.</u> Legislative Intent. It is the intent of this Local Law to revise the fee schedule currently in effect for certain services provided by the Cattaraugus County Health Department.

<u>SECTION 2.</u> Fee Schedule. Effective May 1, 2017, the following fees shall be charged by the Cattaraugus County Health Department.
