<u>New York State Department of State:</u> Acknowledging receipt of Local Law No. 7-2015 (Intro No. 8-2015) and the filing of the same on September 17, 2015.

<u>New York State Department of Health:</u> Signed copy of the Order of Consolidation for the Town of Little Valley and the Village of Little Valley into a single primary registration district.

CHAIRMAN MARSH announced that it is the time and place for a public hearing on **Act No. 463-2015**, **Local Law Number 9-2015**, entitled, "A Local Law Prohibiting the Sale of Personal Care Products Containing Microbeads in Cattaraugus County", and that anyone wishing to speak for or against this local law may now do so.

Dr. Sherri A. Mason, professor at SUNY Fredonia, gave a video presentation entitled, "Great Lakes Plastic Pollution Survey", based upon research she has performed in the Great Lakes.

Jon Rivera, aide to Erie County Executive Mark Poloncarz, spoke regarding Erie County's ban on microbeads and in support of our local law.

Nate Drag, Watershed Project Coordinator for the Great Lakes Watershed, spoke in support of banning microbeads.

Rick Winter, lobbyist for the cosmetic industry, agreed that microbeads should be removed from our waters, however, control and enforcement of the elimination of microbeads from all products, not just cosmetic products needs to occur; suggested requesting state officials to advocate elimination in the entire industry.

There being no one else wishing to speak, CHAIRMAN MARSH declared the public hearing closed.

AUTHORIZING THE CHAIR TO EXECUTE CONTRACT WITH NEW YORK STATE INDUSTRIES FOR THE DISABLED FOR OLEAN OFFICE FACILITY JANITORIAL SERVICES

Pursuant to Section 162 of the State Finance Law and Sections 215 and 450 of the County Law.

WHEREAS, Act 555-2013, as amended by Act 447-2015, authorized a contract with New York State Industries for the Disabled, 155 Washington Avenue, Suite 400, Albany, New York 12210, through SubCon Industries, Inc., for the provision of janitorial services for the Olean Office Facility, the term of which expires December 31, 2015, and

WHEREAS, County Department of Public Works is desirous of renewing the aforementioned contract for a term commencing January 1, 2016 and terminating December 31, 2017, and

WHEREAS, the New York State Industries for the Disabled, through SubCon Industries, Inc., has agreed to perform the aforementioned janitorial services at a monthly cost of \$14,660.11 not to exceed \$175,921.32 per year, for a total contract amount of \$351,842.64, to be paid on a monthly basis as invoiced, with the option to increase if the minimum wage increases, now, therefore, be it

RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a contract, contingent upon and subject to the inclusion in the 2016 budget of sufficient funds to cover the costs of the aforementioned services, on behalf of Cattaraugus County, with New York State Industries for the Disabled, through SubCon Industries, Inc., for the provision of the above-described services, for a term commencing January 1, 2016 and terminating December 31, 2017, according to the above-described terms, and be it further

WHEREAS, Cattaraugus County shall act as lead agency, on behalf of Allegany County, to process costs incurred by both County Sheriff's Offices in the fighting of illegal drug activity, combating drug trafficking and conducting investigations, and in support of efforts related to the Southern Tier Regional Drug Task Force, and

WHEREAS, each county shall receive grant funding in the amount of \$37,500.00 to cover costs incurred through the aforementioned purposes, and

WHEREAS, this program is 100% state funded, now, therefore, be it

WHEREAS, Act 174-2014 authorized the Chairman to apply for a three (3) year Indigent Legal Services Funding grant from the New York State Office of Indigent Legal Services for the purpose of improving the availability and quality of indigent legal services, the term of which commenced June 1, 2014 and terminates May 31, 2017, and

WHEREAS, in order to receive such funds, the County submitted a plan to the Office of Indigent Legal Services for the disbursement of such funds, which has been approved, and

WHEREAS, one component of the plan for the disbursement of such funds includes salary enhancements made payable to the Assistant Public Defenders and the Administrator of Assigned Counsel (AAC), and

WHEREAS, the criteria established in the Office of Indigent Legal Services Standards and Criteria for the Provision of Mandated Representation effective January 1, 2013, provides that counties must ensure that attorneys and programs providing mandated legal services have and use adequate

resources and procedures to receive or provide compensation commensurate with that of opposing counsel and opposing counsel's office, and

WHEREAS, Act 473-2015 authorized a plan for the disbursement of ILSF funds for the purpose of salary enhancements for Assistant Public Defenders and the Administrator of Assigned Counsel, which were made on a quarterly basis, covering services provided October 1, 2015 through September 30, 2018, and

WHEREAS, the salary enhancements were made in accordance with the aforementioned criteria and provide parity in the assistant attorney salaries between the Public Defender's Office and the District Attorney's Office, and

WHEREAS, the County will receive the amount of \$80,733.00 per year, for a three (3) year period, for the purpose of improving the availability and quality of indigent legal services, and

WHEREAS, the ILSF grant provides for the reimbursement to the County on a quarterly basis, now, therefore, be it

RESOLVED, that in addition to the regular compensation of the Assistant Public Defenders and the Administrator of Assigned Counsel (AAC), the following amounts be disbursed as indicated on the following chart, so long as the employee has been employed for the complete preceding calendar quarter, minus withholding tax, FICA, retirement and other required withholdings therefrom:

WHEREAS, the aforementioned services should be continued to further efforts to reduce costs associated with the defense of indigents and continue to improve the quality of services, and

WHEREAS, The Legal Aid Bureau of Buffalo, Inc., can provide appellate representation for a maximum of 24 cases appealed from the courts of Cattaraugus County for an amount of \$35,000.00 per year, for a total three (3) year contract amount of \$105,000.00, to be paid as invoiced, and

WHEREAS, sufficient funds are included in the budget to cover the cost of the aforementioned costs, now, therefore, be it

RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a contract, on behalf of Cattaraugus County, with The Legal Aid Bureau of Buffalo, Inc., for

the provision of the above-described indigent appellate legal services, for a term commencing October 1, 2015 and terminating September 30, 2018, according to the above-described terms.
