LOCAL LAW NUMBER 1-2012 COUNTY OF CATTARAUGUS, NEW YORK

Pursuant to Section 10 of the Municipal Home Rule Law.

A LOCAL LAW ESTABLISHING PROBATION DEPARTMENT ADMINISTRATIVE FEES

BE IT ENACTED by the County Legislature of the County of Cattaraugus as follows:

<u>SECTION 1. Legislative Intent.</u> It is the intent of this local law to establish a fee for the supervision of persons sentenced to a term of probation.

<u>SECTION 2. Probation Administrative Fees.</u> Effective July 1, 2012, there is hereby imposed an administrative fee of \$30 per month for each person currently serving or who shall be sentenced to a term of probation upon conviction of any crime.

<u>SECTION 3.</u> Waiver of Fees. The Probation Department shall waive all or part of such fee where, because of the indigence of the offender, the payment of said surcharge would cause an unreasonable hardship on the person convicted, his or her immediate family, or any other person who is dependent on such person for financial support.

<u>SECTION 4. Severability.</u> If any provision of this Local Law shall be adjudged by any court of competent jurisdiction to be invalid, then such adjudication, shall not effect, impair or invalidate the remainder thereof, but shall be confined in its operation to the particular provision directly involved in the controversy in which such judgment shall have been rendered.

SECTION 5. Effective Date. This Local Law shall take effect immediately.
