AUTHORIZING PUBLIC HEARING ON LOCAL LAW NUMBER 5-2012

Pursuant to Section 1650 of the Vehicle and Traffic Law and
Section 10 of the Municipal Home Rule Law.

I. WHEREAS, there has been duly presented and introduced at a meeting of this Legislature held on June 13, 2012, a proposed Local Law entitled "A Local Law Regulating the Transfer of Secondhand Articles, ~~and Repealing Local Law No. 3-1981 regarding the Transfer of Precious Metals and Jewelry~~", and

II. WHEREAS, no local law shall be adopted until a public hearing thereon has been had by the Cattaraugus County Legislature upon at least five days notice, now, therefore, be it

I. RESOLVED, that a public hearing shall be held on the proposed local law by this County Legislature on the 27th day of June, 2012, at 3:03 p.m. at the Legislature's Chambers, County Office Building, 303 Court Street, Little Valley, New York, and that at least five days notice of such hearing shall be given by the Clerk by the due posting thereof upon the bulletin board of each County Court House within the County and by publishing such notice at least once in the official newspapers of the County.
