**LOCAL LAW NUMBER 1 – 2013
COUNTY OF CATTARAUGUS, NEW YORK**

Pursuant to Section 10 of the Municipal Home Rule Law.

**A LOCAL LAW REPEALING LOCAL LAW NUMBER 5-2012 (INTRO NO. 5-2012),
AS AMENDED, ENTITLED “REGULATING THE TRANSFER OF SECONDHAND ARTICLES”**

BE IT ENACTED by the County Legislature of the County of Cattaraugus as follows:

SECTION 1. Local Law Number 5-2012 (Intro No. 5-2012), as amended by Local Law No. 15-2012 (Intro No. 15-2012), entitled, A Local Law Regulating the Transfer of Secondhand Articles”, is hereby repealed.

SECTION 2. Effective Date.

The local law shall become effective immediately.
