LOCAL LAW NUMBER 2-2013 COUNTY OF CATTARAUGUS, NEW YORK

Pursuant to Section 10 of the Municipal Home Rule Law and Section 606 of the Public Health Law.

A LOCAL LAW AMENDING LOCAL LAW NUMBER 3-2011 (INTRO NUMBER 3-2011) REGARDING FEES FOR CATTARAUGUS COUNTY HEALTH DEPARTMENT SERVICES

BE IT ENACTED by the County Legislature of the County of Cattaraugus as follows:

<u>SECTION 1.</u> Legislative Intent. It is the intent of this Local Law to revise the fee schedule currently in effect for certain services provided by the Cattaraugus County Health Department to comply with state law.

SECTION 2. Fee Schedule.

2.1 The following fees are hereby removed from the fee schedule contained in Local Law Number 3-2011 (Intro Number 3-2011):

<u>Program Area</u> <u>Service</u> <u>Fee</u>
A. Food Protection Permissions to Operate \$25.00

<u>SECTION 3.</u> Severability. If any provision of this Local Law shall be adjudged by any court of competent jurisdiction to be invalid, then such adjudication, shall not effect, impair or invalidate the remainder thereof, but shall be confined in its operation to the particular provision directly involved in the controversy in which such judgment shall have been rendered.

SECTION 4. Effective Date. This Local Law shall take effect immediately.
