**LOCAL LAW NUMBER 5-2014  
COUNTY OF CATTARAUGUS, NEW YORK**

Pursuant to Section 10 of the Municipal Home Rule Law and  
Sections 201 and 205 of the County Law.

**A LOCAL LAW ESTABLISHING SALARY FOR SHERIFF FOR THE YEARS 2014 AND 2015**

BE IT ENACTED by the County Legislature of the County of Cattaraugus as follows:

SECTION 1. Salary. The Office of Cattaraugus County Sheriff shall receive a salary of \$97,252.60 for 2014, which incorporates a 3% salary increase, and a salary of \$99,197.65 for 2015, which incorporates an additional 2% salary increase.

SECTION 2. Effective Date. This Local Law is subject to permissive referendum in accordance with Section 24 of the Municipal Home Rule Law.
