# CONVERSION OF PART-TIME POSITION OF KEYBOARD SPECIALIST TO FULL-TIME POSITION OF KEYBOARD SPECIALIST IN THE OFFICE OF THE PUBLIC DEFENDER (Indigent Legal Services-Counsel at Arraignment-Round 2)

Pursuant to Sections 204 and 205 of the County Law and Section 22 of the Civil Service Law.

WHEREAS, the Public Defender has been awarded funding to provide indigent defense to the citizens of Cattaraugus County, and

WHEREAS, Act 223-2017 authorized a contract with the New York State Office of Indigent Legal Services, for the acceptance and receipt of the Counsel at First Appearance Grant, for a term commencing June 1, 2017 and terminating May 31, 2020, and

WHEREAS, various appropriation and revenue accounts were adjusted in order to accommodate the aforementioned grant funding which included appropriations to convert a part-time Keyboard Specialist position in the Office of the Public Defender, Position Number 117-185-002, to a full-time position effective June 1, 2017, and

WHEREAS, this position conversion is necessary to address the ever increasing workload of the Office of the Public Defender, now, therefore, be it

RESOLVED, that effective June 1, 2017, the part-time position of Keyboard Specialist in the Office of the Public Defender shall be filled on a full-time basis, General Bargaining Unit Salary Schedule, Pay Grade 11 (\$15.96 per hour), Position Number 117-185-002, and be it further

RESOLVED, that upon the termination of the Counsel at First Appearance Grant funding, the full-time Keyboard Specialist position in the Office of the Public Defender, Position Number 117-185-002, will be automatically terminated.

## AUTHORIZING THE CHAIR TO EXECUTE CONTRACT WITH NEW YORK STATE OFFICE OF PROBATION AND CORRECTIONAL ALTERNATIVES FOR ALTERNATIVES TO INCARCERATION PROGRAM

Pursuant to Article 13-A of the Executive Law and Section 450 of the County Law.

WHEREAS, Act 191-2016 authorized a contract with the New York State Division of Probation and Correctional Alternatives for an Alternatives to Incarceration Program for the 2016-2017 program year, the term of which expires June 30, 2017, and

WHEREAS, the Alternatives to Incarceration Program consists of a pre-trial release component with a total program cost of \$26,150.00, with an amount of \$10,308.00 being funded through the New York State Office of Probation and Correctional Alternatives for the contract term of July 1, 2017 through June 30, 2018, and

WHEREAS, the Pre-Trial Release Program provides for the screening and, for those eligible, background evaluation on all individuals admitted to the County jail, provides the courts with sufficient information and recommendations for possible release on recognizance pending resolution of the case in court, helps relieve overcrowding in the jail, and allows the jail to operate with a simplified classification system, and

WHEREAS, this program is 39% state funded and 61% locally funded, and

WHEREAS, sufficient funds are included in the budget to cover the cost of the aforementioned program, now, therefore, be it

RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a contract, on behalf of Cattaraugus County, with the New York State Office of Probation and Correctional Alternatives, for the provision of the above-described program, for a term commencing July 1, 2017 and terminating June 30, 2018, according to the above-described terms, and be it further

RESOLVED, that upon termination of either state or federal funding for this program, then this program shall be automatically abolished, and be it further

RESOLVED, that such contract shall provide that upon the reduction of any such funding, the County, in its sole discretion, may terminate the contract on thirty (30) days written notice, and be it further

RESOLVED, that in the event of any such reduction, the department head involved shall immediately report such occurrence to the Chairman of the Committee to which the department is assigned, who shall add the matter to the agenda of the Committee's next meeting.

Adopted May 24, 2017 by voice vote.
