WHEREAS, the County Board of Elections is desirous of charging back, to all villages in the County, 50% of all expenses connected with elections that the County conducts, and matters preliminary or relating thereto that were directly incurred by villages, as well as those county expenses that were specifically chargeable to villages pursuant to a provision of law, including the expenses of election inspectors and expenses

relating to the ballots, test decking ballots, testing of machines, preparing machines and programming voting machines, now, therefore, be it

RESOLVED, that effective January 1, 2011, the Cattaraugus County Board of Elections shall charge back, to all villages in the County, 50% of all expenses connected with elections that the County conducts, and matters preliminary or relating thereto that were directly incurred by villages, as well as those county expenses that were specifically chargeable to villages pursuant to a provision of law, including, but not limited to, the expenses of election inspectors and expenses relating to the ballots, test decking ballots, testing of machines, preparing machines and programming voting machines.

- SECTION 4. Statutory Repeal. Effective January 1, 2011, Act No. 605-1999, Local Law Number 5-1999 (Intro Number 4-1999) entitled "A Local Law Establishing Fees for Cattaraugus County Real Property Tax Service Agency Services" is hereby repealed.
- SECTION 5. Effective Date. This Local Law shall take effect immediately.
