Chairman Couture called the meeting to order at 4 pm.

APPROVAL OF MINUTES

Michael Zaprowski moved with a second from Mark Smith to approve the minutes of the June 28, 2012 meeting as submitted. Carried.

NEW BUSINESS

General Municipal Law Section 239 (I) & (m) Referrals

Town of Allegany Zoning Text Amendment – Height Limit – Commercial **Wind Energy Conversion Systems**

Paul Bishop reported that the Town of Allegany is proposing a local law establishing height limits for wind energy conversion systems in the Town's Zoning Ordinance. Section 5.03 - Height Regulations of the Zoning Ordinance will be revised to remove the word "windmills".



Section 5.25 (C) (12) - Height Limit is added as follows: "The maximum height of any WECS shall be 497 feet." Most wind energy ordinances in upstate New York have a maximum height limit. The proposed height limit of 497 feet would not affect any current project. The previously approved Everpower project has an approved installed height of 492 feet.

This is an unlisted action under SEQR with a Short EAF Completed. A public hearing is scheduled for August 21, 2012 at 7:00 pm at the Allegany Senior Center. Staff recommendation is that the proposed action has no significant county-wide or inter-municipal impact.

David McCoy moved with a second from Florence Fuller that the Town of Allegany's referred Zoning Text Amendment establishing height limits for wind energy conversion systems in the Town's Zoning Ordinance has no significant county-wide or inter-municipal impact. Carried.

<u>Town of Ellicottville Site Plan Review/Special Use Permit – 6599 Route 219 N – Tim Horton's</u>

Paul Bishop reported that the Town of Ellicottville Planning Board has referred a site plan review and special use permit request for a new Tim Horton's restaurant on the site that now houses the Town's Highway Facility at 6599 US Route 219 N (Tax Map No. 46.004-1-49). They will use a portion of the existing garage (building closest to Route 219) for the restaurant. The remaining portion of the ground floor of the existing building will be reserved for a future retail/office tenant. A new second story would be constructed which would contain up to six one-bedroom apartments. An existing building at the rear of the lot will be demolished. This project requires Site Plan approval and a Special Use Permit from the Town's Planning Board and two area variances from the Town's Zoning Board of Appeals. Due to the referral agreement between the Town of Ellicottville and the Cattaraugus County Planning Board, the variances are exempt from referral. No stormwater plan was provided. The applicant should consider low impact development features to absorb stormwater on the site. No landscaping plan was provided. This is an Unlisted Action under SEQR with a Short EAF Completed. There are no flood plains or wetlands on the site. A public hearing was held on July 23, 2012. Staff recommendation is approval, with two advisories: (1) that the applicant supply a stormwater management plan and consider low impact development features to absorb stormwater on site, and (2) that the applicant provide a landscaping plan.

Ann Padlo moved with a second from Paul Mager that the Town of Ellicottville Planning Board's referred site plan review and special use permit request for a new Tim Horton's restaurant and 1100 sq feet of other retail/office space and six apartments on a second story at 6599 US Route 219 North be approved with two advisories. Those advisories being: 1) that the applicant supply a stormwater management plan and consider low impact development features to absorb stormwater on site and 2) that the applicant provide a landscaping plan. Carried.

<u>City of Olean – Site Plan Review/Special Use Permit – 800 Rear East State Street – Family</u> Recreational Facility

James Isaacson reported that the City of Olean Planning Board has referred a site plan review and special use permit request for a family recreational facility at 800 rear East State Street near Forness Park. The site currently consists of a former miniature golf course on 8 acres of land. A new 38,100 s.f. building will be built adjacent to the course. The building will house a bowling alley, a restaurant, and a large multi-use space. The existing miniature golf course will be re-

used, and some additional outdoor recreation is shown to the rear of the new building. 181 parking spaces will be located on-site.

A stormwater plan was submitted with the application, and shows underground piping to be the main technique of stormwater management for the building and parking lot. We would like to see some more low impact development techniques employed in the management of storm water. These techniques, such as bio-retention swales, reduced imperviousness, and functional landscaping, can reduce off-site stormwater runoff and reduce impacts to surrounding surface waters and groundwater. This may also be able to reduce site development and long-term maintenance costs for the project. A small portion of the site is located in a flood plain. There are no wetlands. This is an Unlisted Action under SEQR with no determination of significance issued. A public hearing has not been scheduled to date. Staff recommendation is approval with the advisory that the City Planning Board consider low impact development techniques for stormwater management in the final site design, which will reduce off-site runoff and ensure adequate ground-water recharge.

Upon discussion, David McCoy moved with a second from Robert Keis that the referred City of Olean Planning Board's site plan review and special use permit request for a family recreational facility at 800 rear East State Street be approved with an advisory that the City Planning Board consider low impact development techniques for stormwater management in the final site design, which will reduce off-site runoff and ensure adequate ground-water recharge. Carried.

County Comprehensive Plan

James Isaacson reported that the public forum on Environment and Natural Resources held in Randolph on July 12th had a good turnout – 18-19.

James stated that he likes the idea of white papers and will be pursuing that further.

Crystal Abers reported that she will be doing a radio interview about the comprehensive plan on the Springville radio station.

The next forum is August 9th on Transportation and Infrastructure and will be held at the Cattaraugus County Olean Airport at 6 pm.

Chairman's Report

Chairman Couture reported that it is hard times for the fruit growers. Even as dry as it has been, they can't water the trees. Also there is stress from birds.

Mark Smith reported that 2 farmers in South Dayton are hauling water out of Gernatt's ponds.

Paul Bishop reported that he has made tentative arrangements for Tom Barnes of STW to attend the August 30th meeting to talk about the CEDS document – a document that contains a list of economic development projects.

STW Report

Robert Keis reported that the annul presentations for the ARC projects was held at the last STW Board meeting. The proposed Equestrian Trails in Chautauqua County eventually connecting with Equestrian Trails in Cattaraugus County received a high ranking.

Member's Forum

Paul Mager stated that the Broadband Initiative is very important to the rural small farms. His Alpaca farm attends festivals in Ellicottville and Little Valley. They have a wireless credit card machine, but can't use it in either area.

Discussion on the need for faster internet service in our rural county.

Mike Zaprowski reported that there the Allegany Rockin' Ribfest is in Salamanca on August 16, 17 & 18.

What Smart Growth and New Urbanism Can Do For Rural Communities - Topic of the Cattaraugus County Planning Board's Annual Leadership Conference

The Cattaraugus County Planning Board held its Annual Leadership Conference on Wednesday, July 25th, at the Cattaraugus County Olean Airport in Ischua with 88 people in attendance. Members of the Airport Support Group gave informative tours of the Airport facilities and answered numerous questions concerning its operation.

George R. Grasser, Executive Director for Partners for a Livable Western New York, was the



His topic was "What Smart Growth and New Urbanism Can Do For Rural keynote speaker. Communities". He presented Smart Growth Principles and New Urbanism Land Use Practices to the county and municipal officials in attendance which will be very helpful as we continue to plan for the future of our rural communities.

Some of the Smart Growth Principles that Mr. Grasser presented are: locating new development near existing development and infrastructure; protecting open space, farmland and critical environmental areas; creating a vibrant mix of land uses; increasing the range of housing opportunities and choices; and designing places for personal interaction and walkability. A few of the New Urbanism Land Use Practices that Mr. Grasser presented are a finer grain of land uses, such as smaller areas of the same zoning classification; infill development and preservation and renovation of existing buildings; walkable and bikeable communities; streets of the minimum width necessary to accommodate traffic flow; connective street patterns; building to lot lines in higher density areas; neighborhoods with shopping, parks, squares, and varied housing types and sizes; and hidden garages that are set-back from the front or accessed from the rear of the lot.



Community Involvement

Haggerty Field at Hysol Park – The JCC Women's Softball Team needed a new home field. The City of Olean determined that Haggerty Field at Hysol Park would be the best site. The City leases this land from SolEpoxy. SolEpoxy quickly supported the project with nearly \$10,000 of field improvements in order to achieve college softball standards.

JCC's Women's Softball Team will join the effort and begin tree planting along North Union this Fall. **Innovations in Education** – Southern Tier Catholic School and Archbishop Walsh Academy are pioneering new ideas to improve classroom learning and teacher effectiveness. They have implemented "classrooms of the future" that leverage modern technology alongside instructional best practices – some of which hearken back to one-room schools of our past. SolEpoxy is supporting their worthy effort by sponsoring the third grade classroom-of-the-future with a \$20,000 gift.
